# **GENERAL INFORMATION**

# 

■ Some manual illustrations may show units with safety shields or guards removed to provide better views and/or needed explanations. Units are never to be modified or operated with safety shielding or guards removed.

The purpose of this manual is to assist you in operating and maintaining your scrap grapple. Read it carefully. It furnishes information and instructions that will help you achieve years of dependable performance. These instructions have been compiled from extensive field experience and engineering data. Some information may be general in nature, due to unknown and varying operating conditions. However, through experience and these instructions, you should be able to develop procedures suitable to your particular situation. The illustrations and data used in this manual were current at the time of printing. However, due to possible inline production changes, your machine may vary slightly in detail. We reserve the right to redesign and change the machines as may be necessary without notification.

Throughout this manual, references are made to right and left directions. These are determined by standing behind the tractor facing the direction of forward travel.

Safety is a primary concern in the design and manufacture of our products. Unfortunately, our efforts to provide safe equipment can be wiped out by an operator's single careless act.

In addition to the design and configuration of equipment, hazard control and accident prevention are dependent upon the awareness, concern, judgement, and proper training of personnel involved in the operation, transport, maintenance and storage of equipment.

#### **INSTALLATION**

■ Hydraulics must be connected as instructed in this manual. Do not substitute parts, modify, or connect in any other way.

■ After connecting hoses, check that all control lever positions function as instructed in the Operator's Manual. Do not put into service until control lever and equipment movements are correct.

#### **TRAINING**

■ Safety instructions are important! Read all attachment and power unit manuals; follow all safety rules and safety decal information. (Replacement manuals and safety decals are available from your dealer. To locate your nearest dealer, check the Dealer Locator at www.WoodsEquipment.com, or in the United States and Canada call 1-800-319-6637.) Failure to follow instructions or safety rules can result in serious injury or death.

■ If you do not understand any part of this manual and need assistance, see your dealer.

■ Know your controls and how to stop engine and attachment quickly in an emergency.

• Operators must be instructed in and be capable of the safe operation of the equipment, its attachments, and all controls. Do not allow anyone to operate this equipment without proper instructions.

■ Keep hands and body away from pressurized lines. Use paper or cardboard, not hands or other body parts to check for leaks. Wear safety goggles. Hydraulic fluid under pressure can easily penetrate skin and will cause serious injury or death. ■ Make sure that all operating and service personnel know that if hydraulic fluid penetrates skin, it must be surgically removed as soon as possible by a doctor familiar with this form of injury or gangrene, serious injury, or death will result. #### **PREPARATION**

■ Check that all hardware is properly installed. Always tighten to torque chart specifications unless instructed otherwise in this manual.

■ Counterweight ballast may be required for machine stability. Check your power unit manual or contact your dealer.

■ Air in hydraulic systems can cause erratic operation and allows loads or equipment components to drop unexpectedly. When connecting equipment or hoses or performing any hydraulic maintenance, purge any air in hydraulic system by operating all hydraulic functions several times. Do this before putting into service or allowing anyone to approach the equipment.

■ After connecting hoses, check that all control lever positions function as instructed in the Operator's Manual. Do not put into service until control lever and equipment movements are correct.

■ Protective hose sleeves must cover all hydraulic hoses within 20 inches of the operator and be secured onto metal hose fittings. Replace hoses or sleeves if damaged or if protective sleeve cannot be properly positioned or secured.

■ Make sure all hydraulic hoses, fittings, and valves are in good condition and not leaking before starting power unit or using equipment. Check and route hoses carefully to prevent damage. Hoses must not be twisted, bent sharply, kinked, frayed, pinched, or come into contact with any moving parts. Operate moveable components through full operational range to check clearances. Replace any damaged hoses immediately.

■ Always wear relatively tight and belted clothing to avoid entanglement in moving parts. Wear sturdy, rough-soled work shoes and protective equipment for eyes, hair, hands, hearing, and head; and respirator or filter mask where appropriate.



This scrap grapple fits Bobcat, New Holland, John Deere, Case, and other skid steers equipped with a universal skid steer coupler. Read the skid steer operator's manual for instructions on proper skid steer operation and safety.

The scrap grapple bucket is designed for lifting and moving loose materials which can be held by the clamping action of the hydraulic grapple.

#### ATTACHING GRAPPLE BUCKET TO SKID STEER



■ Be sure attachment is properly secured, adjusted, and in good operating condition. Coupler lockpins must be fully extended and properly engaged into attachment retaining slots.

Read the skid steer operator's manual connecting and removing instructions.

Position hydraulic hoses so they will not be pinched when connecting the attachment.




Figure 1. Skid Steer Coupler Handles - Unlocked

The skid steer coupler handles should be in the unlocked position and the lock pins retracted, Figure 1.

Move to the skid steer operator seat, fasten seat belt, engage operator restraint, and start engine. Lower skid steer lift arms to their lowest position.




Figure 2. Attaching Scrap Grapple to Skid Steer

Carefully move and align the skid steer coupler to the grapple bucket. The top of the skid steer coupler must index into the upper attachment flange, Figure 2.

Operation 9

Roll the skid steer coupler into the grapple bucket hitch so the coupler handles can be engaged. Shut off the engine, set brake, remove key, remove seat belt, and release operator restraint. Dismount the skid steer.




Figure 3. Skid Steer Coupler Handles - Locked




Figure 4. Retaining Slot Locations -Back View of Attachment

Move the skid steer coupler handles to the locked position. The lock pins must be completely extended and secured into the retaining slots provided on the grapple bucket, Figure 3 and Figure 4.

Connect hydraulic hoses to skid steer auxiliary quick couplers.

#### HYDRAULIC QUICK ATTACH COUPLERS

In some cases, hydraulic quick attach couplers may interfere with the factory hose location. (See Figure 5). In those cases, the hoses may be relocated to the top of the bucket.

#### **Hose Relocation Instructions**

- **1.** Remove loader pressure and return lines from the bucket, the nuts from the tee fittings and the bulkhead plate.
- 2. Shim the bulkhead tee fittings with one 9/16 SAE flat washer (#B0920) each, between the fitting and the top channel of the bucket. Washer is included with buckets from the factory. It is installed between the tee fitting and the bulkhead plate.

**3.** Reinstall the fittings in the holes in the top of the bucket beneath the step. Reinstall the loader pressure and return lines. Be sure to direct the hoses so they do not get pinched between the loader coupler and the loader arm during a dump/rollback cycle. Reinstall the bulkhead plate to protect the hose cavity.

#### **OPERATING GRAPPLE BUCKET**

Operators using the grapple bucket must not exceed the skid steer operating capacity. The density of loose material is variable and care must be used to prevent overloading the skid steer. When loading dense or wet material, reduce the amount of material carried in the bucket. Lift and carry loads uniformly.

Transport to dumping location before raising. Only dump load when on a firm level surface.

Slowly raise load to required dumping height. Position bucket, rotate grapple bucket forward and release load. While raising, observe and keep rotation of grapple bucket slightly forward so that any accidental spillage will fall forward and away from the operator's cab.

Use care when dumping into trucks, wagons, spreaders, etc. Open grapple teeth will swing beyond bucket edge and can damage the opposite side of implement, out of the operator's sight.

#### **REMOVING FROM SKID STEER**

On a hard level surface, lower attachment to the ground and close grapples.

Shut off engine, set brake, remove key, remove seat belt and release operator restraint before leaving the skid steer operator's seat.

Move skid steer coupler handles to the unlocked position, Figure 1. Lock pins must be disengaged from attachment retaining slots.

Disconnect hydraulic hoses from quick couplers. Install dust plugs and couple hoses together for storage.

Move to the skid steer operator seat, fasten seat belt, engage operator restraint, and start engine.

Release brake and roll skid steer coupler until it is disengaged from the attachment. The attachment should be placed in storage position.

# ■ Keep children and bystanders away from storage area.

Inspect the grapple bucket thoroughly and prepare for storage. Repair or replace any damaged components.

Remove grapple bucket as described in "Removing From Skid Steer", above.

Rest the grapple bucket flat on the ground for storage with grapples completely closed. The bucket must rest with the buckets edge and bottom flat to the ground.

#### ATTACHING GRAPPLE BUCKET TO ISO QUICK ATTACH COUPLER

Position the hydraulic hoses so they will not be pinched when connecting the attachment.

The quick attach coupler handle should be in the unlocked (open) position with lock pins retracted, Figure 5.




Figure 6. Quick Attach Coupler Handle - Unlocked

Move to the operator seat, fasten seat belt, and start engine.

Lower loader lift arms to their lowest position.

Carefully move and align the quick attach coupler to the bucket or attachment. The top of the quick attach coupler must completely engage the attachment or bucket hook, Figure 6.

Roll the attachment coupler into the attachment flange so the coupler handle can be engaged.




Figure 7. Connecting Bucket or Attachment to Loader


Shut off the engine, set brake, remove key, and remove seat belt. Dismount the tractor.

Move the attachment coupler handle to the locked (closed) position. The lockpins must be completely extended and secured into the retaining slots, Figure 7.

# \Lambda WARNING

# ■ Attachment coupler handles must always be rotated to LOCK POSITION to prevent coupler latch from disengaging and attachment from falling off.

Connect hydraulic hoses to loader auxiliary quick couplers (optional).





#### LOADER OPERATION



#### ■ Do not allow bystanders in the area when operating, attaching, removing, assembling, or servicing equipment.

The loader should be operated with the tractor engine running at a safe RPM. Excessive speeds are dangerous, and may cause bucket spillage and unnecessary strain on the tractor and loader.

#### **CUTTING EDGE (OPTIONAL)**

Bolt-on reversible cutting edges are available for all scrap grapple buckets.

#### **SLAT KIT (OPTIONAL)**

Bolt-in slat kits are available for all Root Grapple buckets. Slat kits reduce the tine spacing from 6.75" to 3.19".

#### **RELIEF VALVE KIT (OPTIONAL)**

An in-line relief valve kit is available for all Scrap and Root Grapple buckets. This kit limits the maximum loader pressure to 3000 psi, the rated pressure of the hydraulic cylinders. Loaders with operating pressures greater than 3000 psi should use the relief valve kit to ensure the integrity of the grapple bucket hydraulics.

12 Operation

#### **CLEANING**

#### After Each Use

- Remove large debris such as clumps of dirt, grass, crop residue, etc. from machine.
- Inspect machine and replace worn or damaged parts.
- Replace any safety decals that are missing or not readable.

#### Periodically or Before Extended Storage

- Clean large debris such as clumps of dirt, grass, crop residue, etc. from machine.
- Remove the remainder using a low-pressure water spray.

- 1. Be careful when spraying near scratched or torn safety decals or near edges of decals as water spray can peel decal off surface.
- **2.** Be careful when spraying near chipped or scratched paint as water spray can lift paint.
- **3.** If a pressure washer is used, follow the advice of the pressure washer manufacturer.
- Inspect machine and replace worn or damaged parts.
- Sand down scratches and the edges of areas of missing paint and coat with Woods spray paint of matching color (purchase from your Woods dealer).
- Replace any safety decals that are missing or not readable (supplied free by your Woods dealer). See Safety Decals section for location drawing.

#### **PRE-OPERATION CHECK LIST**

#### (OWNER'S RESPONSIBILITY)

- \_\_\_\_ Review and follow all safety rules and safety decal instructions on page 5 through page 8.
- \_\_\_\_ Check that all safety decals are installed and in good condition. Replace if damaged.
- \_\_\_\_ Check that all shields and guards are properly installed and in good condition. Replace if damaged.
- \_\_\_\_ Check that all hardware and cotter pins are properly installed and secured.
- \_\_\_\_ Check that equipment is properly and securely attached to skid steer.
- Consult local utilities before digging. Know location of and avoid contacting all underground cables, pipelines, overhead wires and other hazards in digging area.

\_\_\_ Do not allow riders.

- \_\_\_\_ Check and keep all bystanders away from equipment working area.
- \_\_\_\_ Check all lubrication points and grease as instructed in "Service, Lubrication Information".
- Check that all hydraulic hoses and fittings are in good condition and not leaking before starting skid steer. Check that hoses are not twisted, bent sharply, kinked, frayed or pulled tight. Replace any damaged hoses immediately.
- \_\_\_\_ Make sure skid steer ROPS and seat belt/operator restraint are in good condition. Keep seat belt/operator restraint securely fastened during operation.

# **OWNER SERVICE**

The information in this section is written for operators who possess basic mechanical skills. Should you need help, your dealer has trained service technicians available. For your protection, read and follow all safety information in this manual.

## A WARNING

■ Safety instructions are important! Read all attachment and power unit manuals; follow all safety rules and safety decal information. (Replacement manuals and safety decals are available from your dealer. To locate your nearest dealer, check the Dealer Locator at www.WoodsEquipment.com, or in the United States and Canada call 1-800-319-6637.) Failure to follow instructions or safety rules can result in serious injury or death.

■ Make sure shields and guards are properly installed and in good condition. Replace if damaged.

■ NEVER GO UNDERNEATH EQUIPMENT. Never place any part of the body underneath equipment or between moveable parts even when the engine has been turned off. Hydraulic system leak-down, hydraulic system failures, mechanical failures, or movement of control levers can cause equipment to drop or rotate unexpectedly and cause severe injury or death.

• Service work does not require going underneath implement.

• Read Operator's Manual for service instructions or have service performed by a qualified dealer.

■ Before leaving operator's seat, lower lift arms and put attachment on the ground. Engage brake, stop engine, remove key, and remove seat belt.

■ Before performing service work that requires repair or replacement of parts, remove attachment from power unit. Hydraulic system failures, mechanical failures, or movement of control levers can cause equipment to drop or rotate unexpectedly and cause severe injury or death.

■ Keep all persons away from operator control area while performing adjustments, service, or maintenance.

■ Do not disconnect hydraulic lines until machine is securely blocked or placed in lowest position and system pressure is released by operating valve levers.

■ If you do not understand any part of this manual and need assistance, see your dealer.

■ Always wear relatively tight and belted clothing to avoid getting caught in moving parts. Wear sturdy, rough-soled work shoes and protective equipment for eyes, hair, hands, hearing, and head; and respirator or filter mask where appropriate.

■ Tighten all bolts, nuts, and screws to torque chart specifications. Check that all cotter pins are installed securely to ensure equipment is in a safe condition before putting unit into service.

#### **LUBRICATION**

Do not let excess grease collect on or around parts, particularly when operating in sandy areas.




Figure 5. Lubrication

Figure 5 shows the lubrication points. The accompanying chart gives the frequency of lubrication in operating hours based on normal operating conditions. Severe or unusual conditions may require more frequent lubrication. Some reference numbers have more than one location; be sure you lubricate all locations.

Use a lithium grease of #2 consistency with a MOLY (molybdenum disulfide) additive for all locations, unless otherwise noted. Be sure to clean fittings thoroughly before attaching grease gun. When applied according to the lubrication chart, one good pump of most guns is sufficient.

# **DEALER SERVICE**

The information in this section is written for dealer service personnel. The repair described herein requires special skills and tools. If your shop is not properly equipped or your mechanics are not properly trained in this type of repair, you may be time and money ahead to replace complete assemblies.



■ Never work under a raised loader. Always lower loader to the ground with bucket or loader attachment in full roll-back position. Shut off tractor, set parking brake, and remove key. Operate valve levers to release any hydraulic pressure. If loader obstructs tractor maintenance, loader must be removed from tractor.

■ Never allow anyone to get under the loader bucket or reach through the lift arms when the bucket is raised.

■ Keep all persons away from operator control area while performing adjustments, service, or maintenance.

■ Do not disconnect hydraulic lines until all system pressure is relieved. Lower unit to ground, stop engine, and operate all hydraulic control levers.

■ Keep hands and body away from pressurized lines. Use paper or cardboard, not hands or other body parts to check for leaks. Wear safety goggles. Hydraulic fluid under pressure can easily penetrate skin and will cause serious injury or death.

■ Make sure that all operating and service personnel know that if hydraulic fluid penetrates skin, it must be surgically removed as soon as possible by a doctor familiar with this form of injury or gangrene, serious injury, or death will result. CON-TACT A PHYSICIAN IMMEDIATELY IF FLUID ENTERS SKIN OR EYES. DO NOT DELAY.



■ Always wear relatively tight and belted clothing to avoid getting caught in moving parts. Wear sturdy, rough-soled work shoes and protective equipment for eyes, hair, hands, hearing, and head; and respirator or filter mask where appropriate.

#### **CYLINDER SERVICE**

The cylinders are designed to be reliable and easy to service. If a cylinder should malfunction during the warranty period, return the complete cylinder assembly, without disassembling, to your authorized service department or contact your authorized service department for instructions. Unauthorized disassembly of a cylinder in the warranty period will VOID WARRANTY.

**NOTE:** Repair to cylinders is limited to replacing seals, wear rings, and O-rings. Replacing rod, barrel, or pistons is not cost effective. Purchasing a complete cylinder is more economical.




Figure 6. Spanner Nut Cylinder

The cylinder was assembled with a spanner nut assembly. See Figure 6. Spanner nut cylinders can also be identified by the letter "J" included in the stamping located at the base end port.




Figure 7. Spanner Nut Cylinder Assembly

On spanner nut style cylinders, unscrew spanner nut (4) using a spanner wrench, or carefully use a punch and hammer. (Spanner wrench 1021841 is available from Woods to help with these procedures.)

Tap rod guide (5) into barrel (8) about 1/2". Remove round retaining ring (3B). Pull on rod (1) to remove parts from barrel.

Clamp cross pin end of rod assembly (1) in a vise with protective jaws. Remove lock nut (7) from rod assem-

bly. Remove piston (6), stop tube (2) if equipped, and rod guide (5) from rod.

Remove and discard all seals, wear rings and O-rings. Clean all components in solvent and blow dry with low pressure air.

Inspect inside diameter of barrel (8). Replace cylinder if damaged.

#### Assembly

Lubricate O-rings and seals with clean hydraulic fluid. Install back-up washer (3E) on rod guide (5), then install O-ring (3F) in exterior O-ring groove of rod guide. Install rod seal (3D) into inner groove of rod guide with open portion of V-groove toward piston.

Place rod wiper (3C) in outer rod guide groove. Slide rod guide assembly (5) onto rod (1). Place crown piston seal (3G) in piston groove.




Figure 8. Spanner Nut Cylinder Assembly

Lightly coat rod threads with hydraulic oil and slide Oring (3A) over threads and into groove. Install stop tube (if equipped) and piston (6) onto rod (1) as shown in Figure 8. Completely clean threads of hydraulic oil, apply Locquic<sup>®</sup> Primer 7649 and Loctite<sup>®</sup> 242 to the rod threads, and install lock nut (7). Torque to 175 lbsft.

Compress crown piston seal and carefully insert piston and rod assembly into barrel. Use care to prevent damage while installing.

Carefully push or tap rod guide (5) into barrel (8) just past groove inside barrel. Insert retaining ring (3B) into groove and pull rod (1) to seat rod guide (5) against ring. Apply Loctite 242 to rod guide threads. Screw spanner nut (4) into rod guide (5) using a spanner wrench, or carefully use a punch and hammer.




Figure 6. Cutting Edge

#### **DEALER CHECK LISTS**

#### **Pre-Delivery Check List**

#### (Dealer's Responsibility)

Inspect the equipment thoroughly after assembly to ensure it is set up properly before delivering it to the customer.

The following check lists are a reminder of points to inspect. Check off each item as it is found satisfactory or after proper adjustment is made.

- \_\_\_\_ Check that all safety decals are installed and in good condition. Replace if damaged.
- \_\_\_\_ Check that shields and guards are properly installed and in good condition. Replace if damaged.
- \_\_\_\_ Check all bolts to be sure they are tight.


- Check that all cotter pins and safety pins are properly installed. Replace if damaged.

#### **Delivery Check List**

#### (Dealer's Responsibility)


- \_\_\_\_ Show customer how to make adjustments.
- Instruct customer how to lubricate and explain importance of lubrication.
- Point out the safety decals. Explain their meaning and the need to keep them in place and in good condition. Emphasize the increased safety hazards when instructions are not followed.
- Present Operator's Manual and request that customer and all operators read it before operating equipment. Point out the manual safety rules, explain their meanings and emphasize the increased safety hazards that exist when safety rules are not followed.
- Explain to customer the potential crushing hazards of going underneath raised equipment. Instruct customer that service work does not require going underneath unit and never to do so.
- Show customer the safe, proper procedures to be used when mounting, dismounting, and storing equipment.
- Explain to customer that when equipment is transported on a road or highway, safety devices should be used to give adequate warning to operators of other vehicles.
- Make customer aware of optional equipment available so that customer can make proper choices as required.
- Point out all guards and shields. Explain their importance and the safety hazards that exist when not kept in place and in good condition.


