Extended Operation / Extreme Conditions

A CAUTION



Repetitive Stress Injuries (RSI)

It is believed that overusing the muscles and tendons of the fingers, hands, arms, and shoulders may cause soreness, swelling, numbness, weakness, and extreme pain in those areas. Certain repetitive hand activities may put you at a high risk for developing a Repetitive Stress Injury (RSI). An extreme RSI condition is Carpal Tunnel Syndrome (CTS), which could occur when your wrist swells and squeezes a vital nerve that runs through the area. Some believe that prolonged exposure to vibration may contribute to CTS. CTS can cause severe pain for months or even years.

To reduce the risk of RSI/CTS, do the following:

- · Avoid using your wrist in a bent, extended, or twisted position. Instead try to maintain a straight wrist position. Also, when grasping, use your whole hand, not just the thumb and index finger.
- Take periodic breaks to minimize repetition and rest your hands.
- · Reduce the speed and force with which you do the repetitive movement.



- · Do exercises to strengthen the hand and arm muscles.
- Immediately stop using all power equipment and consult a doctor if you feel tingling, numbness, or pain in the fingers, hands, wrists, or arms. The sooner RSI/CTS is diagnosed, the more likely permanent nerve and muscle damage can be prevented.



ASSEMBLY

This model is factory assembled.

OPERATION

WARNING

Moving parts can amputate fingers or cause severe injuries. Keep hands, clothing and loose objects away from all openings. Always stop engine, disconnect spark plug, and make sure all moving parts have come to a complete stop before removing obstructions, clearing debris, or servicing unit.

WARNING

Engine exhaust IS HOT, and contains Carbon Monoxide (CO), a poison gas. Breathing CO can cause unconsciousness, serious injury, or death. Exhaust can cause serious burns. ALWAYS position unit so that exhaust is directed away from your face and body.

WARNING

Operation of this equipment may create sparks that can start fires around dry vegetation. This unit is equipped with a spark arrestor to prevent discharge of hot particles from the engine. Metal cutters can also create sparks if the cutter strikes rocks. metal, or other hard objects. Contact local fire authorities for laws or regulations regarding fire prevention requirements.

Fuel

WARNING

Diesel fuels and alternative fuels, such as E-15 (15% ethanol), E-85 (85% ethanol) or any fuels not meeting ECHO requirements are NOT approved for use in ECHO 2-stroke gasoline engines. Use of diesel or alternative fuels may cause performance problems, loss of power, overheating, fuel vapor lock, and unintended machine operation, including, but not limited to, improper clutch engagement. Diesel or alternative fuels may also cause premature deterioration of fuel lines, gaskets, carburetors and other engine components.

Fuel Requirements

Gasoline - Use 89 Octane [R+M/2] (mid grade or higher) gasoline known to be good quality. Gasoline may contain up to 10% Ethanol (grain alcohol) or 15% MTBE (methyl tertiary-butyl ether). Gasoline containing methanol (wood alcohol) is **NOT** approved. Use of ECHO branded fuel is recommended to extend engine life in all air-cooled 2-stroke and 2/4-stroke hybrid engines.

Two Stroke Oil - A two-stroke engine oil, such as ECHO branded 2-stroke oils, meeting ISO-L-EGD (ISO/CD 13738) and J.A.S.O. FD Standards must be used. ECHO branded 2-stroke oils meet these standards. Engine problems due to inadequate lubrication caused by failure to use an ISO-L-EGD (ISO/CD 13738) and J.A.S.O. M345-FD certified oil will void the twostroke engine warranty.

WARNING

2-Stroke engine oil contains petroleum distillates and other additives that may be harmful if swallowed. Heated oil can release vapors that can cause flash fire, or ignite with explosive force. Read and follow the oil manufacturer's instructions, and observe all safety warnings and precautions for handling flammable liquids. For more detailed safety and first aid information, visit www.echo-usa.com for a copy of the Material Safety Data Sheet.

- KEEP OUT OF REACH OF CHILDREN.

- AVOID repeated or prolonged skin contact.

ECHO branded 2-stroke oils may be mixed at 50:1 ratio for application in all ECHO engines sold in the past regardless of ratio specified in those manuals.

Handling Fuel

Fuel is VERY flammable. Use extreme care when mixing, storing or handling, or serious personal injury may result.

- Use an approved fuel container. Mark fuel containers as containing 2-stroke mixture fuel.
- DO NOT smoke near fuel.
- DO NOT allow flames or sparks near fuel.
- ◆ Fuel tanks/cans may be under pressure. Always loosen fuel caps slowly allowing pressure to equalize.
- NEVER refuel a unit when the engine is HOT or RUNNING!
- DO NOT fill fuel tanks indoors. ALWAYS fill fuel tanks outdoors over bare ground.
- ◆ DO NOT overfill fuel tank. Wipe up spills immediately.
- · Securely tighten fuel tank cap and close fuel container after refueling.
- Inspect for fuel leakage. If fuel leakage is found, do not start or operate unit until leakage is repaired.
- ◆ Move at least 3 m (10 ft.) from refueling location before starting the engine.

Gasoline vapor is heavier than air, and can travel along the ground to nearby sources of ignition such as electrical motors, pilot lights, and hot or running engines. Vapors ignited by an ignition source can flash back to the fuel container, resulting in an explosion, fire, serious or fatal injuries, and extensive property damage.



Mixing Instructions

- Fill an approved fuel container with half of the required amount of gasoline.
- Add the proper amount of 2-stroke oil to gasoline.
- Close container and shake to mix oil with gasoline.
- Add remaining gasoline, close 4. fuel container, and remix.

NOTICE

Spilled fuel is a leading cause of hydrocarbon emissions. Some locations may require the use of automatic fuel shut-off containers to reduce fuel spillage.

Storage - Fuel storage laws vary by locality. Contact your local government for the laws affecting your area. As a precaution, store fuel in an approved, airtight container. Store in a well-ventilated, unoccupied building, away from sparks and flames.

• Empty the fuel tank prior to storing the unit. Return unused fuel to an approved fuel storage container.

NOTICE

Stored fuel ages. Do not mix more fuel than you expect to use in 30 days, 90 days when a fuel stabilizer is added.

Stored two-stroke fuel may separate. ALWAYS shake fuel container thoroughly before each use.

Used oil and gasoline, and soiled towels are hazardous waste materials. Disposal laws vary by locality.

Starting Cold Engine

WARNING

Hedge Trimmer blades are very sharp. Touching them may lead to severe personal injury. Avoid touching blades whenever possible, and always wear gloves to protect hands.

Note: The blade cover is used for transportation and storage. Remove blade cover before using the unit.

Stop Switch 1.

Move stop switch (A) away from the STOP position.

2. Choke


Move choke (B) to COLD START () (closed) position.


Purge Bulb 3.


Pump purge bulb (C) until fuel is visible and flows freely in the clear fuel tank return line. Pump bulb an additional 4 or 5 times.

4. Recoil Starter

Lay the unit on a flat, clear area. Grip the support handle securely with one hand, and pull the recoil starter handle (D) until engine fires (or 5 pulls maximum).








Choke

After engine fires (or 5 pulls), move choke (B) to the RUN (| | | |) (open) position. Restart engine if necessary and allow unit to warm up at idle for several minutes.

Note: If engine does not start with choke in "RUN" position after 5 pulls, repeat instructions 2 - 5.




WARNING

The blades must not move at idle, otherwise serious personal injury may result. Periodic carburetor adjustment may be necessary to assure blades do not move at idle. If blades move, readjust carburetor according to "Carburetor Adjustment" instructions in this manual or see your ECHO Dealer.

6. Throttle Trigger

After engine warm-up, grip the throttle handle and support handle. Depress the throttle trigger lockout (E), and gradually depress throttle trigger (F) to increase engine RPM to operating speed.



Starting Warm Engine

The starting procedure is the same as Cold Start except DO NOT close the choke.

WARNING

The blades must not move at idle, otherwise serious personal injury may result. Periodic carburetor adjustment may be necessary to assure blades do not move at idle. If blades move, readjust carburetor according to "Carburetor Adjustment" instructions in this manual or see your ECHO Dealer.



1. Stop Switch

Move stop switch (A) away from the STOP position.

2. Purge Bulb

Pump purge bulb (C) until fuel is visible and flows freely in the clear fuel tank return line. Pump bulb an additional 4 or 5 times.



Recoil Starter 3.

Place the unit on a flat, clear area. Grip the support handle securely with one hand, and pull the recoil starter handle (D) until engine starts.


Note: If engine does not start after 5 pulls, use Cold Start Procedure.




Stopping Engine

1. Throttle

Release throttle trigger (F) and allow engine to return to idle before shutting off engine.



2. Stop Switch Move stop switch (A) to STOP position.



WARNING


If engine does not stop when stop switch is moved to STOP position, close choke - COLD START position - to stall engine. Have your ECHO dealer repair stop switch before using unit again.

Hedge Trimming

WARNING

Hedge Trimmer blades are very sharp. Touching them may lead to severe personal injury. Avoid touching blades whenever possible, and always wear gloves to protect hands.

- Always grip support handle with right hand, and throttle handle with left hand.
- 2. Hold trimmer firmly and squeeze throttle trigger to accelerate engine.
- Tilt trimmer so cutting teeth are 3. angled slightly toward the hedge or shrub and proceed to cut.



WARNING

Never remove hands from unit when blades are moving.

WARNING

The engine continues running even when the blades have stopped due to an obstruction. If this occurs, stop the engine, disconnect ignition cable and remove the obstruction.

MAINTENANCE

WARNING

Moving parts can amputate fingers or cause severe injuries. Keep hands, clothing and loose objects away from all openings. Always stop engine, disconnect spark plug, and make sure all moving parts have come to a complete stop before removing obstructions, clearing debris, or servicing unit. Allow unit to cool before performing service. Wear gloves to protect hands from sharp edges and hot surfaces.

WARNING

Operating a poorly maintained unit can result in serious injuries to operator or bystanders. Always follow all maintenance instructions as written, otherwise serious personal injury may result.

Your unit is designed to provide many hours of trouble free service. Regular scheduled maintenance will help your unit achieve that goal. Air Filter


Parts Required: Tune-Up Kit

- Close choke (B) (COLD START [| position). This prevents dirt from entering the carburetor throat when the air filter is removed. Brush accumulated dirt from air cleaner area.
- 2. Remove air filter cover. Brush dirt from inside cover.
- 3. Replace filter if it is damaged, fuel soaked, very dirty, or the rubber sealing edges are deformed.
 - · Lightly brush debris from filter.
 - Soak heavily soiled filters in water/detergent solution to loosen dirt, then brush lightly.
 - · Rinse with clean water and allow to dry completely before reuse.
- 4. Install air filter in air filter case.
- 5. Install air filter cover.

Fuel Filter


Level 1.

Parts Required: Tune-Up Kit



Fuel is VERY flammable. Use extreme care when mixing, storing or handling, or serious personal injury may result.

- 1. Use a clean rag to remove loose dirt from around fuel cap and empty fuel tank.
- 2. Pull the fuel line and filter from the tank.



NOTICE

Do not damage fuel line while removing fuel filter from tank.

Remove the filter from the line and install the new filter.

Note: Federal EPA regulations require all model year 2012 and later gasoline powered engines produced for sale in the United States to be equipped with a special low permeation fuel supply hose between the carburetor and fuel tank. When servicing model year 2012 and later equipment, only fuel supply hoses certified by EPA can be used to replace the original equipment supply hose. Fines up to \$37,500 may be enforced for using an un-certified replacement part.


Spark Plug

Level 2.

Parts Required: Tune-Up Kit

Use only NGK BPMR-8Y spark plug otherwise severe engine damage may occur.

- Remove spark plug and check 1. for fouling, worn and rounded center electrode.
- 2. Clean the plug or replace with a new one. DO NOT sand blast to clean. Remaining sand will damage engine.
- 3. Adjust spark plug gap by bending outer electrode.
- Tighten spark plug to 150-170 kgf cm (130-150 in lbf). 4.



Cooling System

Level 2.

NOTICE

To maintain proper engine operating temperatures, cooling air must pass freely through the cylinder fin area. This flow of air carries combustion heat away from the engine.

Overheating and engine seizure can occur when:

- Air intakes are blocked, preventing cooling air from reaching the cylinder.
- · Dust and grass build up on the outside of the cylinder. This build up insulates the engine and prevents the heat from leaving.

Removal of cooling passage blockages or cleaning of cooling fins is considered "Normal Maintenance." Any failure attributed to lack of maintenance is not warranted.

- Remove spark plug lead.
- 2. Remove muffler cover.
- 3 Remove starter cover.
- 4. Use brush (not included) to remove dirt from the cylinder fins.



OTICE

DO NOT use a metal scraper to remove dirt from the cylinder fins.

Assemble components in reverse order.


Spark Arrestor Screen


Parts Required: Spark Arrestor Screen, Gasket

- 1. Remove spark plug lead.
- 2. Remove muffler cover.
- 3. Place piston at Top Dead Center (TDC) to prevent carbon/dirt from entering cylinder.
- Remove exhaust guide (A), 4. gasket (B), and screen (C) from muffler body.
- Clean carbon deposits from 5. muffler components.

Note: When cleaning carbon deposits, be careful not to damage the catalytic element inside muffler.



7. Assemble components in reverse order.




Exhaust Port Cleaning

Level 2.


Parts Required: As needed: Heat Shield

- 1. Remove spark plug lead from spark plug, and remove muffler cover.
- 2. Place piston at top dead center. Remove muffler (A), heat shield (B), and eye plate (C).



Never use a metal tool to scrape carbon from the exhaust port. Do not scratch the cylinder or piston when cleaning the exhaust port. Do not allow carbon particles to enter the cylinder.

- 3. Use a wood or plastic scraping tool (not included) to clean deposits from cylinder exhaust port.
- 4. Inspect heat shield, and replace if damaged.
- 5. Install heat shield, muffler, and eye plate.
- Tighten muffler mounting bolts 6. (or nuts) to 90-110 kgf•cm (80-95 in•lbf).



- 7. Install muffler cover and attach spark plug lead.
- 8. Start engine, and warm to operating temperature.
- 9. Stop engine, and re-tighten mounting bolts (or nuts) to specifications.

Carburetor Adjustment

WARNING

The blades must not move at idle, otherwise serious personal injury may result. Periodic carburetor adjustment may be necessary to assure blades do not move at idle. If blades move, readjust carburetor according to these instructions, or see your ECHO Dealer.

Engine Break-In

New engines must be operated a minimum duration of two tanks of fuel break-in before carburetor adjustments can be made. During the break-in period your engine performance will increase and exhaust emissions will stabilize. Idle speed can be adjusted as required.

High Altitude Operation

This engine has been factory adjusted to maintain satisfactory starting. emission, and durability performance up to 1,100 feet above sea level (ASL) (96.0 kPa). To maintain proper engine operation above 1,100 feet ASL the carburetor may need to be adjusted by an authorized ECHO service dealer.

NOTICE

If the engine is adjusted for operation above 1,100 feet ASL, the carburetor must be re-adjusted when operating the engine below 1.100 feet ASL, otherwise severe engine damage may result.

Level 2.

Parts Required: None

Note: Every unit is run at the factory and the carburetor is set in compliance with emission regulations. Carburetor adjustments, other than idle speed, must be performed by an authorized ECHO dealer.

Check idle speed and reset if necessary. If a tachometer is available, idle speed screw (A) should be set to the specifications found on "Specifications" page of this manual. Turn idle screw (A) clockwise to increase idle speed; counter clockwise to decrease idle speed.



WARNING

When carburetor adjustment is completed, the cutting attachment should not move at idle, otherwise serious personal injury may result.

Parts Required: Echo RedArmor™ Blade Cleaner & Lubricant, or


20W Engine Oil (blade lubrication), 50-50 mixture of

WARNING

Hedge Trimmer blades are very sharp. Touching them may lead to severe personal injury. Avoid touching blades whenever possible, and always wear gloves to protect hands.

- Move stop switch to stop 1. position.
- Disconnect spark plug wire 2. from spark plug.
- 3. Brush loose debris from blade and coat both sides of blade with the 50-50 cleaning mixture.




- Allow cleaning mixture to soften the remaining gummy residue then wipe it from the blade.
- Apply clean oil to the entire length of the blade. Be certain the blade 5. bolts are lubricated.
- Wipe excess oil from the blade before putting the unit back in service. 6.

Gear Box

Level 1.

Parts Required: Lithium Based Grease.

- Clean dirt from the grease fitting (A).
- 2. Apply 1-2 pumps of grease into fitting, DO NOT over fill. Leave room for the grease to expand during operation
- Wipe excess grease from around 3. grease fitting.



Blades

WARNING

Hedge trimmer blades are very sharp, touching them may lead to severe personal injury. Use long hex wrenches and sockets with extensions when tightening blade screws and blade lock nuts to keep hands at a safe distance from sharp blades.

Blades should only be removed and reinstalled by an authorized servicing dealer, otherwise premature wear or internal damage may occur.



- 5. File each edge carefully. Follow the original shape of the blade.



- 8. Drain fuel tank completely. Press purge bulb 6-7 times to remove remaining fuel from carburetor then drain the tank again. Close choke, start and run the engine until it stops due to lack of fuel.
- 9. Allow engine to cool. Remove the spark plug lead from the spark plug. Remove the spark plug. Pour 7 cc (0.25 oz.) of fresh, clean, two-stroke engine oil into the cylinder through the spark plug hole.
 - Place a clean cloth over the spark plug hole. a.
 - b. Pull the recoil starter handle 2-3 times to distribute the oil inside the engine.
