WARRANTY PROGRAM CANADIAN SCOOTERS IMPORT (CSI)

TERMS AND CONDITIONS CANADIAN SCOOTERS IMPORT INC. (CSI) SERVICE PLAN

This Plan coverage begins on the manufacturer original in-service date of the unit. Along with the wording of the Manufacturer's warranty, the following conditions apply:

- a. CSI agrees to repair or replace, at its option, any part which is proven to be defective in material or factory workmanship under normal use;
- b. The Plan owner releases CSI from all liability due to loss of time, loss of use of the vehicle transportation expenses and any other incidental or consequential damages or expenses;
- c. The Plan does not cover failures which are not due to defect in material or factory workmanship or regular maintenance service;
- d. This Plan does not cover repairs caused by accidental or intentional physical damage, collision, misuse or abuse, normal wear and tear, altered serial numbers or damage caused by non-authorized repair personnel;
- e. This Plan does not cover improper installation, the use of unsuitable parts, attachment of parts, and the unauthorized alteration of a part, deterioration caused by the elements or the replacement of Manufacturer's parts with after market performance parts that are not authorized by CSI;
- f. This Plan excludes consumable parts including but not limited to spark plugs, filters, coolant, lubricants, gaskets, seals, belts, electrical, pedals unless found to be a manufacturer's defect, tires and tubes, engine failure due to improper oil mixture, brakes and muffler;
- g. This program could be transferred to another owner. CSI must be warned written about 15 days after the transfer. Administrative expenses of \$75.00 are payable to Canadian Scooters Import Inc. A photocopy of the new certificate of registration must be joined to all requests;
- h. CSI authorized services reserve the right to use new, rebuilt or reconditioned parts for warranty claims;
 - i. A \$75 Deductible apply for vehicle in their second and third year of warranty;
 - j. All replacements will be like kind and quality. If the same model is not available replacement will be based on feature for feature, not original cost;
- k. This program covers the eligible parts mentioned for mileage limited to 6000 km. The mileage limit of the warranty takes precedence over the duration of the warranty which is 1 year if it is reached before the prescribed date.
- l. Vehicle not admissible: The vehicle is not admissible to the basic warranty program and/or to the extended warranty program when:
 - if use for commercial application and drive by more than one driver regularly;
 - if use as a rental, taxi commercial or delivery vehicle;
 - if use as a police scooter or other safety or urgency applications such as surveillance of park, bicycle road, crowd control or other related applications or similar purpose.
